He strategically contributed in developing the production department's annual MOH budget, ensuring monthly tracking of spending, monitoring OT & daily labor utilization. He also established production area performance standards followed by aligning organization on improvement plans and results. Partnered with R&D in the development of new products, namely, Bario and Frutz.

Highlights of the role include:

- Turnaround the plant to full production capacity within a short span of 3 months by resolving all manufacturing quality issues that lead to the shutdown of plant and brought down waste by over 40% over the course of 1 year.
- Effective in development, testing, commissioning & production of Braio (Malt based drink); and Frutz (Carbonated Fruit drink).
- Dismissed all technical manufacturing challenges and steered measures for product stability improvement/testing in association with PepsiCo's R&D Teams.
- Benefitted the plant by recording enhanced production compliance from 30% up to 85%; reducing waste by 40%; improving efficiencies approx. 25% for all lines; doubled productivity to almost 60 cases per employee worked hour.
- Reduced energy and water usage by almost 30% for both due to production optimization and scheduling in addition to implementing environment sustainability programs.

<u>Key programs rolled-out</u>: Production waste deep dives; Lines crewing optimization; Quality inspection protocols & facility & production process audits; Reversed the manufacturing mentality of the plant staff from volume driven to quality & volume driven; Improved the safety culture by regular safety audits.
